02.16.08 REPORT OF THE SUB COMMITTEES.

Sports Field

A request by Admiral Insurance to hire the Sports field for a sports day was referred to the Chairman and Councillor John to seek clarification on the proposed event and to agree a fee if appropriate.

Village Hall

Councillor Pugh reported that a further 2 quotes will be obtained for kitchen units and will be reported the next meeting. Subject to approval work could be carried out during the Busy Bees holiday closure in August.

Environment

Councillor Fitzgerald reported that the LDP proposals will be put before the City and County of Swansea full Council on Thursday16th June at which time Councillor Fitzgerald will be allowed 5 minutes to respond to the proposals affecting Penllergaer and to challenge the soundness of the Plan. During the subsequent consultation period up to the 7th August the council will be required to resubmit its objections and to challenge the soundness of the Plan particularly the high level strategic transport assessment averaged across the whole of the geographic area

Councillor. It was agreed that an item be included in the Newsletter to keep residents informed and also notice of a planned public meeting.

Councillor Fitzgerald also reported that wild flower planting has been carried out, but weed spraying by the CCoS has been discontinued due to the banning of toxic chemicals in public places.
