Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Penllergaer Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

Reserves

The Council currently holds a very large balance of £114,637 in reserves. It is clear from the budget setting process that the Council is reducing this balance year on year, applying its reserves to finance its activities rather than raising its precept. It would be helpful to the Council and to those interested in the Council's financial position to set out in its budget what, if any, proportion of the total balances are set aside for specific purposes and what proportions will be used to finance ongoing expenditure and to provide a fund to cover unexpected costs.

There are no further matters I wish to draw to the Council's attention.
